Substrates

- Blasted steel profile of SA 2 ½ is ideal

Surface Preparation

Bare metal/spot repairs: Bare metal should be primed with Armourcote WB910 Primer, ensuring all rust and contaminants are removed first.

Coating over previously painted substrate: Clean thoroughly to remove all dirt, dust and loose material. Ensure surface is free from oil, grease, mould and any other contaminants which may affect the adhesion or compatibility of the coating to be applied. Ensure any priming coats are cured dry and within their recoat window, prior to application of Armourcote WB943 Top Coat.

Coating performance is in general, proportional to the degree of surface preparation.

- 1) When spraying, use the correct gun set up as recommended by your equipment supplier.
- 2) Application techniques should be adjusted as necessary to achieve the recommended dry film thickness. It is good practice to check this process on a small sample prior taking on a large project.
- 3) All spray setups are recommended starting points and may need adjustments to suit the equipment and conditions.

CAUTION: Prior to using 943 in air or air assisted pumps, we recommend that the pump and spray equipment is stripped and cleaned to remove any contamination from solvent based paints. This includes replacing the lube with a water based product such as Binks Water based lube, which is available from Resene Automotive and Light Industrial.



Mixing: Stir thoroughly, mixing from the bottom of the pail towards the top. Thinning: Do not thin without getting advice from Resene. Application Air assisted airless, suction, gravity spray. Method: Dry Time: Touch dry- 20 minutes No. of Coats: One to one and a half Clean up: Clean up in water

Drying and curing of waterborne coatings:

- 1) Ensure air temperature is at least 10degs C and rising at time of application
- 2) Ensure humidity is less than 75% rH and falling
- 3) Good airflow across the surface of the painted product of approx. 15km/hr is an important factor in drying and curing times.
- 4) In ideal conditions the product will be dry to touch within 20 minutes if applied correctly.
- 5) Ensure no precipitation is forecast if outside, for 4 hours after completion of application. Protect the product from all water contact including dew for a minimum of 48 hours after application.
- 6) Direct hot sunlight can cause skinning of the painted surface, so protect the product in these conditions.
